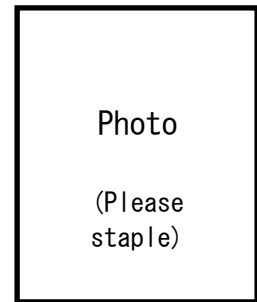

Please note that **Noordwyk Primary School** is declared as a **FEE PAYING SCHOOL** in terms of the relevant legislation, and that by enrolling your child/ren at the school, you are accepting an obligation to contribute financially towards his/her education.

#### **Definition of parents:**

The South African Schools' Act 84 of 1996 defines a parent as:

"Parent" means-

- The biological or adoptive parent or legal guardian of a learner
- The person legally entitled to custody of a learner; or
- The person who undertakes to fulfil the obligations of a person referred to in paragraphs (a) and (b) towards the learner's education at school.

Please take note that the school fee account will be addressed to the “parent” who has applied for the learner at Noordwyk Primary School.

Parents admit and confirm that:

- a) they are aware that the school fees are payable in respect of any and each individual academic school year or part of such year during which their child/ren are enrolled in the school.
- b) Divorced parents must note that the school is not a party to the settlement agreement of the parents. Both parents, irrespective of the contents of the settlement agreement, are liable for the payment of school fees in terms of Section 40 of the SA Schools’ Act. The court order does not overrule the provision of the Act.
- c) They are jointly and severally liable in their personal capacities towards the Governing Body for payment of the school fees, **both parents** are liable for the payment of the **full-amount of school fees**.
- d) School fees are strictly PAYABLE IN ADVANCE.
- e) School fees are a statutory obligation.
- f) They are aware that the Governing Body in its sole discretion may from time to time increase the school fees payable without prior consultation with the parents and in whichever they, the parents, are liable to pay the increased school fees amount.
